MASS will be responsible for the capacity building of Musalihat Anjuman/Jirgas and shall process the procurement of consultants for identifying training needs of the members of MA giving due consideration to the typical disputes leading to instances of gender violence.

MASS shall prepare short and medium term training modules and shall also undertake capacity building of MA members in the discharge of their laid down functions as per LGO 2001.

MASS shall also organize different kinds of training activities in an on going manner during the project life based on the TNA for Musalihat Anjumans/Jirgas. These shall pertain to the conduct of training involving the members of MA, police, judiciary, elected representatives, Union Administration in the selected districts as per the need assessed and capacity building modules. The trainings would be in form of short term gender sensitization courses of a general nature and would be designed to inculcate awareness amongst the society on the issues of gender violence as well as MA as a redressal forum. MASS in close linkage with MAJA will hold meetings with the district level various committees like public safety commission etc to address the cases of gender violence.
